Vacancy for one Director - Call for Nominations

Eligibility:

- Directors who are members of the Senior Management Forum, but who are **not** also members of the Strategic Management Group, are eligible for election.
- Ex-officio members of the Academic Board are excluded.
- *A list of eligible staff is attached for clarification.*
- *Only staff eligible for election in this category are allowed to vote for nominees in this category.*

Time Commitment:

- Academic Board nominees serve for a period of two years.
- They may seek re-election for a further two-year term, but may not serve for more than four years consecutively.
- There are at least five Academic Board meetings per annum, normally held at 9.30a.m. on Monday mornings.

- Nominees must include a supporting statement with their nomination.
- This statement will be included on the ballot form if more than one nomination is received.

The closing date for receipt of nominations is Friday 1st May 2009.

Should there be more than one nomination, an election will be held over the period 18 – 29 May 2009.
