1. Link to the Strategic Plan 2017-2022

The Environmental Management and Sustainability Strategy has a direct link to the following enablers for delivery of the university's <u>Strategic Plan 2017/2022</u>:

- A university committed to financial sustainability and strategic investment in the future
- A university with an estate that fosters a sense of community, supports high quality activity and operates sustainably
- A university that recognises the importance of good governance to support the delivery of its strategic goals.

2. Context and scope of environmental management and sustainability

Our vision, as a modern civic university delivering solutions to the challenges of the 21st century, is to protect and enhance the environment, by minimising our impacts and seeking to develop improvement opportunities. We will respect the environment while carrying out our teaching, research and core processes. We will do this by operating our university in the most environmentally responsible and sustainable way possible and by integrating education for environmental management and sustainability in both academic and research programmes.

The scope of our environmental management and sustainability arrangements will cover all buildings, facilities and processes under our control in England. Where we have assets under our control outside England we will, as a minimum, comply with national legislation and where practicable have arrangements equivalent to those we apply in England.

3. Environmental Management and Sustainability Policy

This Strategy is driven by the university's <u>Environmental Management and</u> <u>Sustainability Policy</u>, which outlines the commitments that will achieve environmental management and sustainability.

4. Purpose of the Environmental Management and Sustainability Strategy

The purpose of the Environmental Management and Sustainability Strategy is to define how the commitments in the Environmental Management and Sustainability Policy will be achieved across the university.

The Strategy's key themes, therefore, are as follows:

- Environmental protection (EP): LJMU commits to preventing or mitigating our adverse environmental impacts from our activities
- Environmental enhancement (EE): LJMU will seek to take advantage of identified beneficial environmental opportunities

- **Compliance (C)**: LJMU will comply with all relevant UK environmental legislation and will meet our obligation to meet other requirements, such as those laid out through the Higher Education Funding Council for England (HEFCE) and local authorities
- Continual improvement (CI): LJMU commits to continual improvement aiming for greater performance when targets are met and managing significant environmental impacts, using certification through the phases of the EcoCampus Environmental Management Scheme to steer progress toward consideration of ISO 14001 Environmental Management
- **Monitoring and management (MM):** LJMU will measure and monitor progress against set targets, driving good practice and acting as a leader in higher education. We will establish KPI reporting, redefining targets and the Environmental Management and Sustainability Policy as appropriate.

5. Environmental Management and Sustainability Principles

We will develop, implement and improve our approach and processes. The thirteen core Environmental Management and Sustainability Principles (ESPs) that underpin our activities are set out below and are aligned to the Strategy's key themes (please see section 4 above). Key performance indicators for each principle are contained in <u>Appendix 1</u>.

6. Governance

The university's Environmental Management and Sustainability Panel provides governance for this Strategy and reports to ELT and the Board of Governors' Infrastructure Committee. Running in parallel with the Environmental Management and Sustainability Panel is the university's Climate Change Panel, which also reports to ELT and the Board of Governor's Infrastructure Committee.

The requirements of the Strategy are implemented through the Environmental Codes of Practice (ECP) arrangements, which are endorsed at the Environmental Management and Sustainability Panel and approved by ELT.

7. Action Plans

This Strategy will have Action Plans that will be implemented via annual priorities which will have defined success criteria.

Key performance indicators have been developed for monthly reporting to the Environmental Management and Sustainability Panel and ELT; and quarterly reporting to the Board of Governors and reporting in the Annual Environmental Management and Sustainability Reports. Benchmarking opportunities will continue to be used, for example by reference to the Higher Education Statistics Agency Estate Management Return.

		We will clearly set out our compliance obligations – both statutory and voluntary – and how we will act to meet these obligations.

		We will promote environmental management and sustainability awareness and principles amongst our staff and students. We will work collaboratively with the Students' Union and our stakeholders for opportunities and improvements in environmental management and sustainability both internally and externally to the university.

		 Provide and regularly update a web page with links to relevant internal and external groups and projects.

		We will identify the resources and technical competencies that the university needs to fulfil its strategy and provide them either internally or externally. As part of an ongoing process, and with consultation, we will embed environmental management and sustainability commitments and tasks into staff roles and responsibilities where appropriate.

KPIs: Increased participation in environmental management and sustainability training courses Identification and monitoring of environmental
